Public offer for providing a software access

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions.

The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

- "Platform" The WN Hub online platform, developed by the Contractor; hosted online at https://wnhub.io.
- "Access" Limited, non-exclusive, non-sublicensable, non-transferable, non-assignable right to use the Platform within the Territory, which the Contractor provides to the Customer for the time period specified in the Access Parameters.
- "Access Parameters" types of Access that define the sections and elements of the Platform, access to which is provided.
- "Territory" The entire world.
- "Access Fee" the cost of the Access to the Platform stated in Paragraph 3 of this Public Offer.
- Website refers to https://wnhub.io/event-info/gamefinder

By clicking the "REGISTER" button the Customer shows a full and absolute acceptance of the present offer (hereinafter referred to as - **Acceptance**). The Agreement shall be deemed to have been made once the Customer clicks the "REGISTER" button and once all the actions mentioned above have been accurately performed.

1. Subject of the Agreement

1.1. The Contractor provides Access to the Platform for the time period specified in the Access Parameters for the WN Gamefinder service upon receiving the Access Fee from the Contractor.

2. Rights and Liabilities of the Parties

- 2.1. In accordance with the conditions of this Agreement the Contractor agrees to:
- 2.1.1. Grant Access to the Customer on the condition that the payment was made within 7 (seven) calendar days after receiving an invoice or a payment link.
- 2.2. In accordance with the conditions of this Agreement the Customer agrees to pay Contractor the amount specified on the chosen Access type on the Website.
- 2.3. In accordance with the conditions of this Agreement the Customer has the right to:
- 2.3.1. Make changes to the user data of the user who has Access to the Platform by sending a request to welcome@wn.media. The change can only be made once for the entire duration of the Access to the Platform. The user should not share usernames, passwords or any other data with other individuals or commercial entities.

3. Terms of Payment

3.1. The cost of Access is calculated based on the information provided below and on the registration form filled in by the Customer and it does not include VAT. The VAT will be added on the checkout page based on the Customer location.

- 4.1. If either Party is prevented from performing any portion of this Agreement by causes beyond its reasonable control (an "Event of Force Majeure"), such Party shall not be liable for non performance of its obligations hereunder.
- 4.2. Any dispute, which may arise out of or in connection with the present Agreement shall be resolved mutually and in good faith by the Parties.
- 4.3. To fill in registration details in the registration form and click the "REGISTER" button at https://wnhub.io/event-info/gamefinder, the Customer confirms that they give their consent to the processing of personal data by the Contractor, as well as by third parties involved by the Contractor on the basis of relevant agreements for the performance of obligations under the present Agreement.
