

Public Offer

Last updated: April 1, 2024.

The present text constitutes a public offer of WN Media Group FZ-LLC (hereinafter referred to as Contractor), developer of the service WN Game Finder, to provide a software access to the WN Hub platform (hereinafter referred to as Agreement) for an individual or a corporate entity (hereinafter referred to as Customer) based on the conditions below.

Please read this document carefully before making a purchase.

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions.

The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

- **"Platform"** – the WN Hub online platform, developed by the Contractor; hosted online at <https://wnhub.io>.
- **"Ticket"** – limited, non-exclusive, non-sublicensable, non-transferable, non-assignable right to use the Platform within the Territory, which the Contractor provides to the Customer for the time period specified in the Ticket Parameters.
- **"Ticket Parameters"** – types of Ticket that define the sections and elements of the Platform, access to which is provided.
- **"Territory"** – The entire world.
- **"Ticket Price"** – the cost of the Ticket to the Platform stated in Paragraph 3 of this Public Offer.
- **Website** refers to <https://wnhub.io/event-info/gamefinder>

By clicking the "REGISTER" button the Customer shows a full and absolute acceptance of the present offer (hereinafter referred to as - **Acceptance**). The Agreement shall be deemed to have been made once the Customer clicks the "REGISTER" button and once all the actions mentioned above have been accurately performed.

1. Subject of the Agreement

1.1. The Contractor provides Ticket to the Platform for the time period specified in the Ticket Parameters for the WN Game Finder service upon receiving the Ticket Price from the Contractor.

2. Rights and Liabilities of the Parties

2.1. In accordance with the conditions of this Agreement the Contractor agrees to:

2.1.1. Grant Ticket to the Customer on the condition that the payment was made within 7 (seven) calendar days after receiving an invoice or a payment link.

2.2. In accordance with the conditions of this Agreement the Customer agrees to pay Contractor the amount specified on the chosen Ticket type on the Website.

2.3. In accordance with the conditions of this Agreement the Customer has the right to:

2.3.1. Make changes to the user data of the user who has Ticket to the Platform by sending a request to welcome@wn.media. The change can only be made once for the entire duration of the Ticket to the Platform. The user should not share usernames, passwords or any other data with other individuals or commercial entities.

3. Terms of Payment

3.1. The cost of Ticket is calculated based on the information provided below and on the registration form filled in by the Customer and it does not include VAT. The VAT will be added on the checkout page based on the Customer location.

ONLINE ACCESS 1 MONTH	\$1,499 (VAT not included)
ONLINE ACCESS 3 MONTHS (33% OFF)	\$2,999 (VAT not included)
ONLINE ACCESS 1 YEAR (45% OFF)	\$9,999 (VAT not included)

3.2. The Customer can pay for the Ticket with their debit or credit card.

4. Other Terms and Conditions

4.1. If either Party is prevented from performing any portion of this Agreement by causes beyond its reasonable control (an “Event of Force Majeure”), such Party shall not be liable for non performance of its obligations hereunder.

4.2. Any dispute, which may arise out of or in connection with the present Agreement shall be resolved mutually and in good faith by the Parties.

4.3. To fill in registration details in the registration form and click the “REGISTER” button at <https://wnhub.io/event-info/gamefinder>, the Customer confirms that they give their consent to the processing of personal data by the Contractor, as well as by third parties involved by the Contractor on the basis of relevant agreements for the performance of obligations under the present Agreement.

5. Term and Termination of Agreement

5.1. This Agreement shall be effective upon Acceptance of the present offer by the Customer and shall remain in effect until the end of paid period of access.

5.2. The Contractor reserves the right to change the conditions of the present Offer and/or withdraw an Offer at any time in Contractor’s own discretion. In case of any changes made to the present Offer, the modifications shall become effective from the date of being published at <https://wnhub.io/event-info/gamefinder>, unless otherwise stated upon publishing.
