Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions.

The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to WN Media Group LLC, 197198, St. Petersburg, Bolshoy Prospekt P.S. 29A, letter B, 1-H, office 300, Russia, TRN 7840089423, RGC 784001001.

Payment for the Service

To receive an invoice and to process payment for services; Invoice is to be provided by the Company;

2. To pay online after completing the registration process on <http://wnconf.com/tickets>, <https://hub.wnconf.com/en#registration>.

You have to fill in registration details in the registration form and to confirm all the details by clicking the "REGISTER" button.

By clicking the “REGISTER” button the Customer shows a full and absolute acceptance of the present Terms. The agreement shall be deemed to have been made once the Customer clicks the “REGISTER” button and once all the actions mentioned above have been accurately performed.

After clicking the “REGISTER” button the Customer is transferred to the payment page. The payments are processed by **Direct Payments Ltd trading as RBK Money**.

The Customer may request a refund for the payment no later than 30 calendar days before the start of the Event. The Company will reimburse the funds after deduction of the service charge of 5% within 10 calendar days.
